Extract of the resolution of the Council

The Tamil Nadu Nurses and Midwives Council resolves to grant **Continuance of Provisional Recognition** to **Kasturba Gandhi Nursing College, Puducherry under Sri Balaji Vidya Peeth, Puducherry (Deemed to be University)** to conduct the following programmes for the academic year 2018-2019 subject to the following conditions:

Sl. No.	Name of the programme	Continuance of Provisional Recognition(CPR) granted for the Academic year	Intake
1.	B.Sc.,(N)	2018-2019	100 students
2.	P.B.B.Sc.,(N)	2018-2019	40 students
3.	M.Sc.,(N)	2018-2019	25 (5 students in each speciality)

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2018-2019 and admission must be made only once a year.
3. Every year list of candidates admitted during the year together with their age and qualification to be uploaded **in the Council's Institutional Management Software (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.


4. **The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.**
5. **The Institution should submit the CMDA/DTCP approval for Academic and Hostel block for College of Nursing from competent authorities before next academic year**
6. Failure to maintain the prescribed requirements will result in de- recognition.
7. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, /Indian Nursing Council, New Delhi from time to time.
8. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
9. If at any time the institution will found un-suitable, the recognition will be withdrawn forthwith by Indian Nursing Council, New Delhi/Tamil Nadu Nurses and Midwives Council.
10. **Annual Programme fee of Rs.10,000/- (B.Sc.,(N), Rs.10,000/- (P.B.B.Sc.,(N)& Rs.15,000/-(M.Sc.,(N) must be paid every year by 30th June.**
11. **Council Prescribed Uniform for Clinicals for the students should be strictly adhered.**
